## Online Account Features — Benefit Recipient



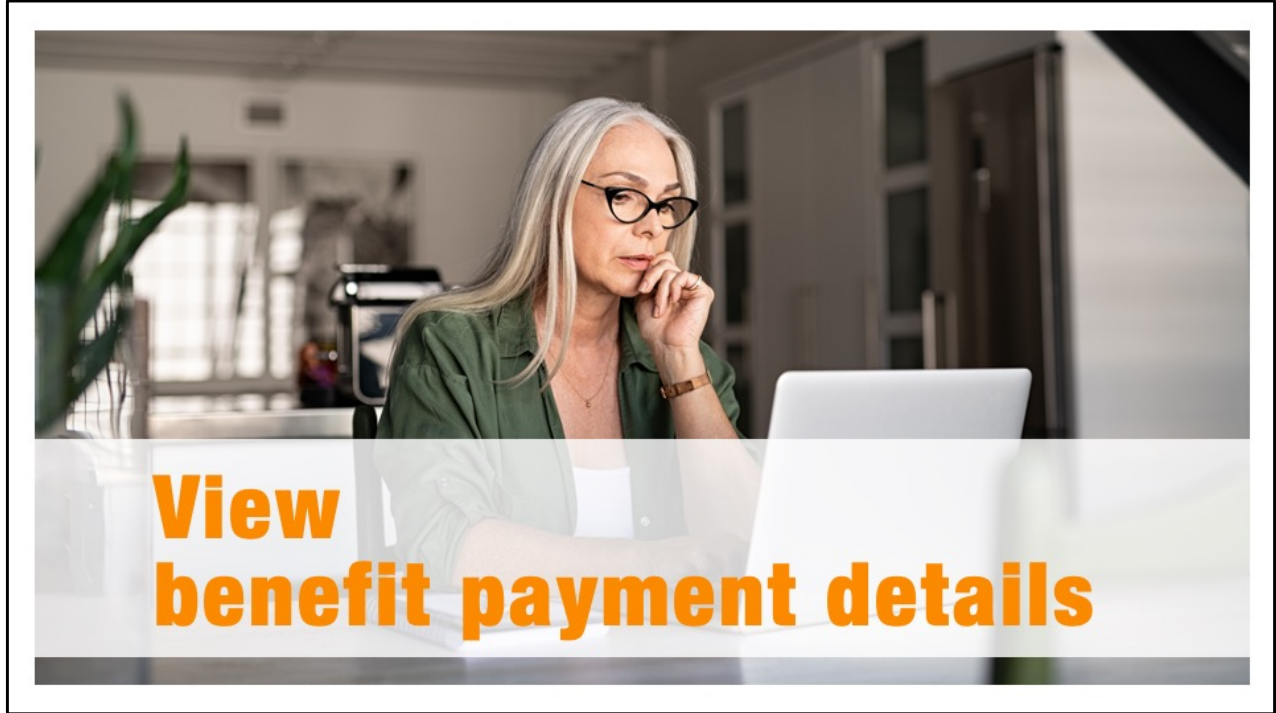
Your account is accessible by desktop computer or mobile device on multiple browsers, meaning you have access at home or on the go!

Review the bank name and account type designated to receive direct deposit of your benefit payment and make any necessary changes.

## Online Account Features — Benefit Recipient



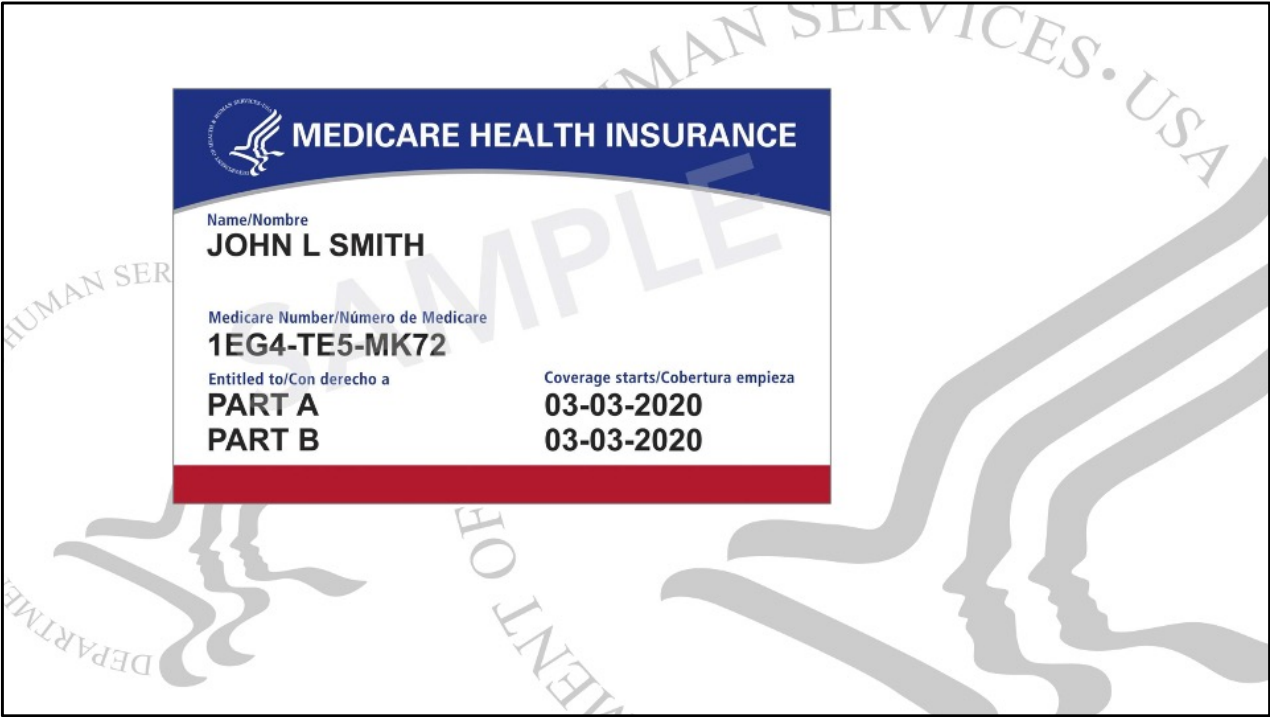
Review current health care plan enrollment information or evaluate other plan options and costs based on area of residence and coverage of eligible dependents.

Change health care plans, add coverage or cancel enrollment during the annual open-enrollment period held every November.

Online Account Features — Benefit Recipient



Submit proof of your Medicare enrollment to STRS Ohio — a requirement after reaching Medicare eligibility.

View important documents, such as your 1099-R tax form and confirmations of changes to your account.

Update your correspondence choices to view certain documents online instead of receiving by mail — such as newsletters and your 1099-R tax form.



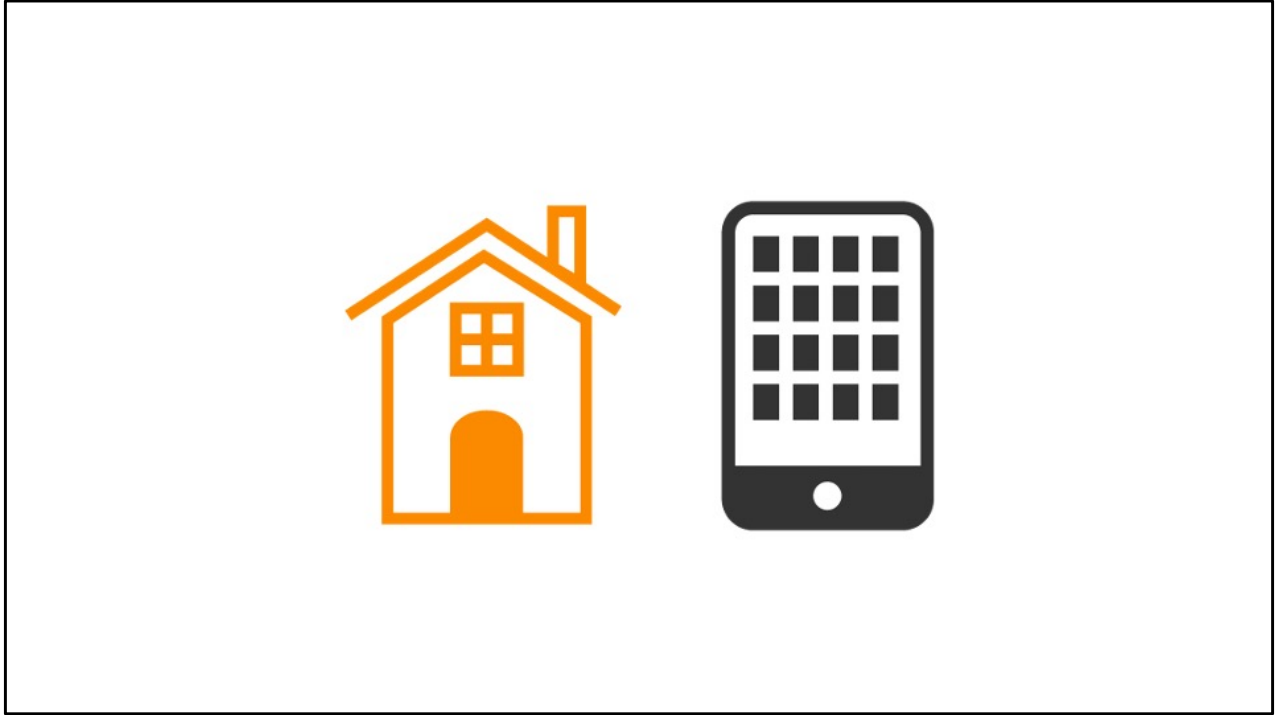
Register for an STRS Ohio retiree educational opportunity. Or view what you have scheduled and cancel or reschedule as necessary.

Review and keep your contact information up-to-date to stay abreast of important STRS Ohio news about your account and benefits.

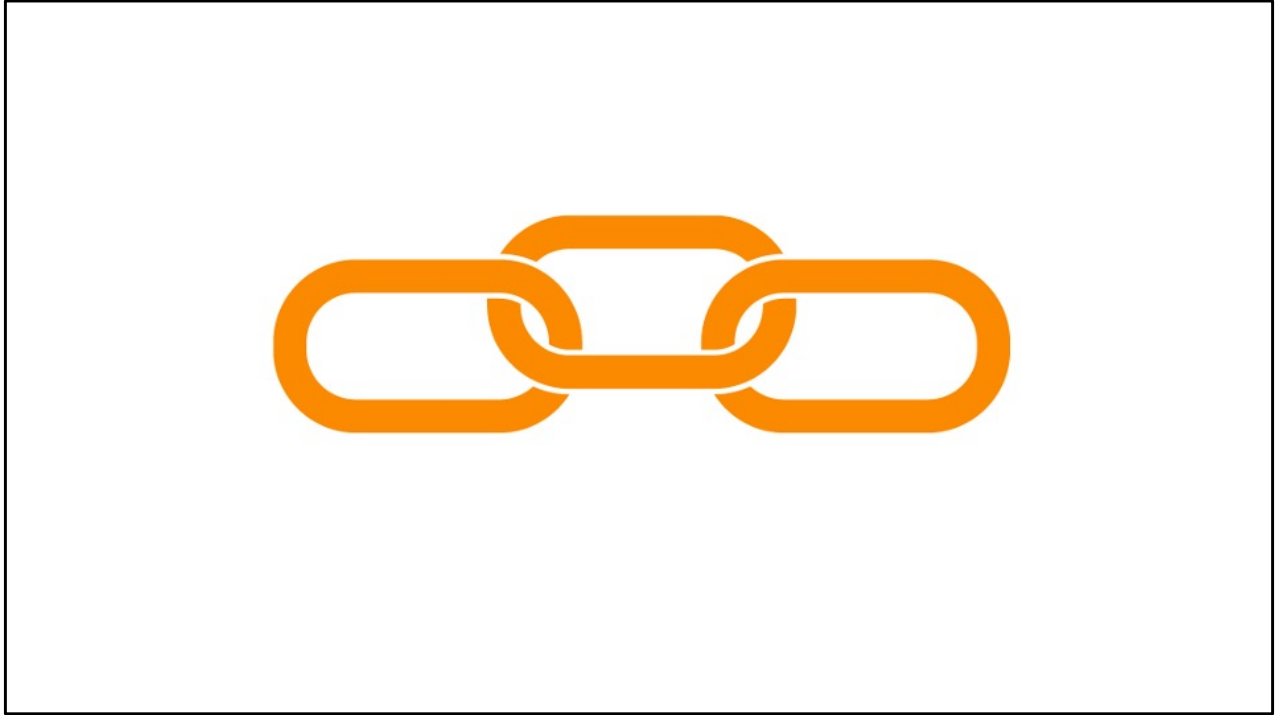
# **Update contact information**

Some account features differ depending on the STRS Ohio retirement plan you were enrolled in at retirement.



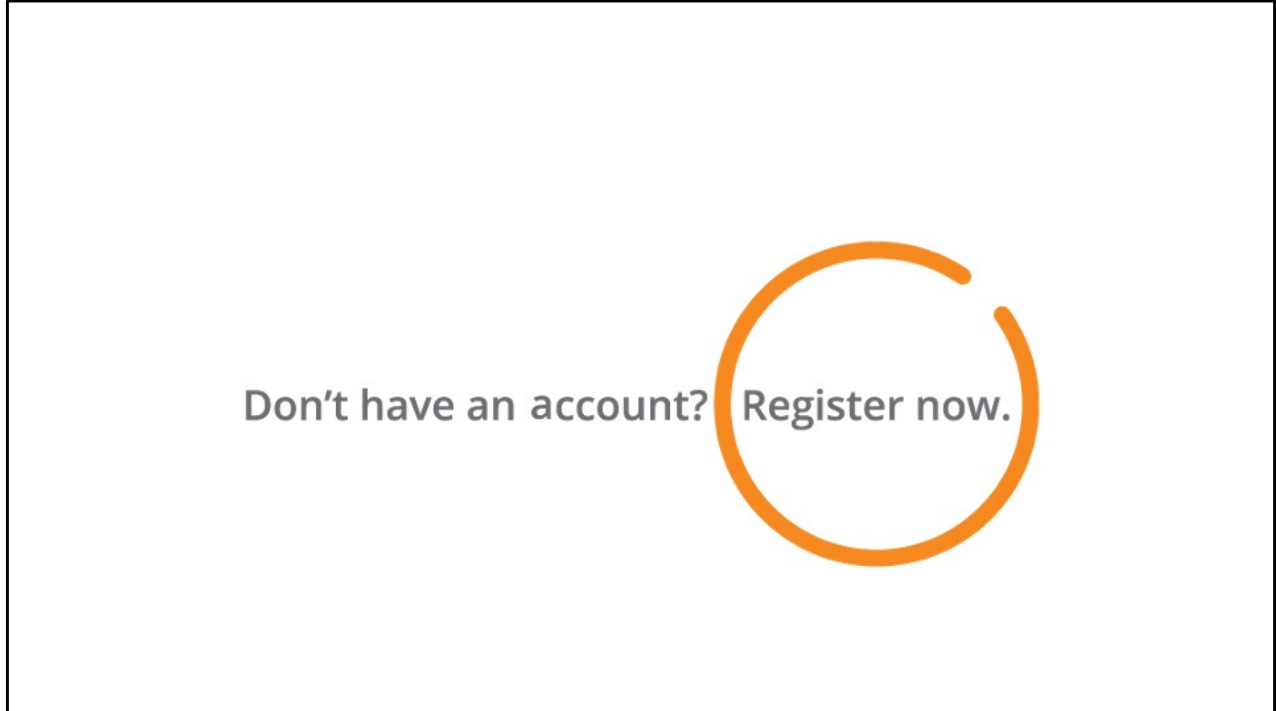
