# **August Financial Reporting & Expenses**

Succeeding this cover page are the STRS Ohio financial reports & expenses for the period ending Aug. 31, 2023. The reports that follow are:

- Statement of Changes in Net Position This statement reflects fiscal year-to-date additions and deductions to the plans' net position. Items such as contributions, investment income and benefit payments are included in this financial report.
- Actual Expenses vs. Budget This report reflects current month operating expenses and fiscal year-to-date expenses compared to fiscal year-to-date pro-rata budgeted amounts approved by the Board. In addition to operating expenses, a similar comparison is made of capital expenses.
- Expense Notes This report provides helpful explanations around larger or infrequent expenses.
- *Detailed Operating Expenses* This report provides the specific companies or individuals paid by STRS Ohio for operating expenses during the month.

STRS Ohio's funds are held in trust for the sole benefit of the retirement system's members and their beneficiaries. Benefits paid by STRS Ohio are funded by contributions from Ohio's public educators and their employers and the investment returns generated by the assets in which those contributions are invested. STRS receives no general revenue funds — in other words, none of the State of Ohio's budget is expended to support STRS Ohio's benefits or operations.

STRS Ohio' operating expenses are paid solely out of investment returns — no member contributions or tax dollars are expended. STRS Ohio's operating budget is approved by the retirement system's board of trustees, who under Ohio law act as fiduciaries to the retirement system's members. Additionally, prior to approval by the STRS Ohio Board, the operating budget is, by law, reviewed by the Ohio Retirement Study Council, which is comprised of members of the Ohio House and Senate, three members appointed by the Governor, as well as the executive directors of Ohio's five public retirement systems.

#### **August 2023 Expense Notes**

#### **General Comments**

Actual fiscal year-to-date operating expenses total \$15.6 million which is approximately \$400,000 under the expected budget.

### **Compensation and Fringe Benefits**

Educational Assistance was provided for seven associates in August.

#### **Professional and Technical Services**

Cloud backup storage is included in <u>Disaster Recovery</u>. A quarterly retainer was paid to the <u>Insurance Consultant</u>. <u>Investment Research Services</u> includes quarterly private market research services. <u>Legal Fees</u> include fees paid to outside counsel. Payment for the medical review board chair services is included in <u>Medical Examinations</u>. <u>Other Consulting Services</u> includes one month of external government relations services. <u>Quotation and Analytic Services</u> include Bloomberg charges.

## Repairs and Maintenance

<u>Building Maintenance and Equipment</u> includes annual preventative fire alarm system and roof maintenance. <u>Data Processing Equipment</u> includes annual support for data warehouse and virtual server technology. Annual fire sprinkler inspections are included in <u>Safety and Security Equipment</u>.

#### **Utilities**

Electricity, Natural Gas and Water are for usage through July.

#### Other Expenses

Training for the replacement cloud-based investment portfolio system is included in Training.

#### **Capital Budget**

Capital items for August include payment for the replacement cloud-based investment portfolio system and garage access gates.

#### **Capital Budget Carryover**

The capital budget carryover includes payment for the replacement data center cooling system.
