

February Financial Reporting & Expenses

Succeeding this cover page are the STRS Ohio financial reports & expenses for the period ending February 29, 2024. The reports that follow are:

- Statement of Changes in Net Position This statement reflects fiscal year-to-date additions and deductions to the plans' net position. Items such as contributions, investment income and benefit payments are included in this financial report.
- Actual Expenses vs. Budget This report reflects current month operating expenses and fiscal year-to-date expenses compared to fiscal year-to-date pro-rata budgeted amounts approved by the Board. In addition to operating expenses, a similar comparison is made of capital expenses.
- Expense Notes This report provides helpful explanations around larger or infrequent expenses.
- *Detailed Operating Expenses* This report provides the specific companies or individuals paid by STRS Ohio for operating expenses during the month.

STRS Ohio's funds are held in trust for the sole benefit of the retirement system's members and their beneficiaries. Benefits paid by STRS Ohio are funded by contributions from Ohio's public educators and their employers and the investment returns generated by the assets in which those contributions are invested. STRS receives no general revenue funds — in other words, none of the State of Ohio's budget is expended to support STRS Ohio's benefits or operations.

STRS Ohio' operating expenses are paid solely out of investment returns — no member contributions or tax dollars are expended. STRS Ohio's operating budget is approved by the retirement system's board of trustees, who under Ohio law act as fiduciaries to the retirement system's members. Additionally, prior to approval by the STRS Ohio Board, the operating budget is, by law, reviewed by the Ohio Retirement Study Council, which is comprised of members of the Ohio House and Senate, three members appointed by the Governor, as well as the executive directors of Ohio's five public retirement systems.

February 2024 Expense Notes

General Comments

Actual fiscal year-to-date operating expenses total \$76.0 million which is approximately \$5.0 million under expected budget.

Compensation and Fringe Benefits

<u>Unused Vacation and Sick Leave</u> includes payment to two retiring associates and four separated associates. Educational Assistance was provided for three associates in February.

Professional and Technical Services

<u>Actuary</u> includes monthly pension and health care valuation services and legislative proposal analysis. <u>Investment Research Services</u> includes quarterly fundamental research and private market research services. <u>Legal Fees</u> include fees paid to outside counsel. <u>Quotation and Analytic Services</u> include quarterly Bloomberg charges. Quarterly retainer fees for two REIC members are included in Real Estate Contract Services.

Repairs and Maintenance

<u>Building Maintenance and Equipment</u> includes sewer line, electrical and boiler repairs, and replacement of two exterior windows. <u>Data Processing Equipment</u> includes annual support for network connectivity hardware.

Utilities

<u>Natural Gas</u> includes two months of service paid in February. <u>Oil</u> includes refilled diesel fuel for generators.

Supplies and Materials

Equipment Supplies includes replacement laptops.

Other Expenses

<u>Conferences and Seminars</u> include conferences attended by information technology associates. Included in <u>Dues and Licenses</u> are membership fees to the Ohio Society of Certified Public Accountants and National Pension Education Association.

State of Ohio Expenses

Quarterly fees for the Ohio Attorney General representation were paid in February.

Capital Budget

Capital items for February include payment for the cloud-based investment portfolio system, replacement of office lighting, fire doors, and security lobby desk.

Capital Budget Carryover

The capital budget carryover includes payment for the replacement data center cooling system and cloud-based financial management system.
