



Cost Proposal

We propose that the project be structured in two parts.

Part 1 would consist of assisting STRS Ohio with updating its governance structure, policies, and procedures, as identified by the following requested services:

- Advise the Board on its overall governance structure, including documentation of roles and responsibilities
 of the Board, Staff, and Committees, as well as development of policies and procedures.
- Engage in a comprehensive review of Board Policies with the Ad Hoc Governance Committee, taking into
 consideration the recommendations made in the 2022 FAS Fiduciary Performance audit, particularly
 those recommendations regarding board governance and enterprise risk management.
- Recommend and assist in the development of additional governance policies as needed to assist the Board and Staff in fulfilling their fiduciary duties.
- Assist in the development of a formal annual Board self-assessment process, including recommendation
 of a continuing education plan for the Board and its members.
- Work cooperatively and constructively with the Board, Staff, and other consulting firms retained by STRS
 Ohio, as necessary for the completion of the services listed above.
- We propose rendering the Part 1 services on a single, fixed-fee basis of US\$150,000. This fee would
 include travel costs for one DLA Piper team member to spend up to five business days in Ohio for inperson meetings with staff.



Cost Proposal

(continued)

Part 2 would consist of providing ongoing governance advice, as identified by the following requested services:

- Attend and participate in STRS Ohio Board meetings (including the annual Board Planning and Education Session and STRS Ohio Ad Hoc Governance Committee meetings) as requested by STRS Ohio.
- Serve as a resource for ongoing guidance and education to the Board regarding general governance matters and complete special projects, as requested.
- We propose rendering the services in Part 2 on a fixed-monthly fee basis of US\$17,500 per month. This
 proposal (i) anticipates attendance at nine meetings per year, for up to eight hours per meeting (including
 the full Board and/or subcommittees); (ii) includes travel costs for one DLA Piper team member to attend
 such meetings in person; and (iii) provides that any ongoing governance advice or special projects shall be
 limited to five hours per month.

Services requested by STRS Ohio outside of the scope of the fixed-fee proposal shall be at hourly rates set forth on the following page or subject to a separately negotiated fee agreement.

Hourly Rates
